The Select Board is holding weekly budget workshops to set recommendations for the fiscal year 2017 Town operating budget. Lately, the workshops have been on Wednesday afternoons, starting at 2 p.m.

The Planning Board continues to review the Land Use and Site Plan Review ordinances for any potential changes that should be suggested.

Three residents have taken out nomination papers for the Select Board term that starts July 1. Papers are still available for both the Fire Chief and Select Board positions.

A revised Shellfish License Application form has been put in place for those looking to get a shellfish license. Annual recreational licenses will be issued starting June 1<sup>st</sup>- which happens to be a Wednesday this year. Please remember that if you are crossing private property to get to the clam flats (to dig) you must have written permission from the land owner on your person at all times while you are digging.

Second half tax payment is due April 29<sup>th</sup>. Post marks will be accepted as the Town Office will be closed on Friday the 29th.

The Town Clerk has begun the compilation of reports for the 2015-16 annual Town report. Do you have any ideas for the cover? Let Chris know by April 14<sup>th</sup>.

The Town Office will close at noon on Tuesday the 12<sup>th</sup>, as there is mandatory vital records' training for Angie & Chris. There is only so much that they will let me log in at the front counter!
